The Los Angeles Heritage Awards is one of the most highly anticipated awards ceremonies in Los Angeles.

Each year, Project Restore pays tribute to individuals and/or organizations that have made outstanding contributions to the economic development and cultural growth of the City of Los Angeles. Proceeds from Los Angeles Heritage Awards go towards preserving and enhancing Los Angeles historic structures while promoting sustainable growth through the revitalization of its neighborhoods.

Organization's Background

Project Restore is a non-profit funded by federal, state and municipal sources combined with support from private donors. Project Restore's unique public-private partnership uses these donations to support the restoration and upkeep of some of Los Angeles' most well-known and beloved landmarks. Its mission is to maintain Los Angeles' rich cultural history by ensuring that its historic buildings are preserved for future generations. Immediate past restoration efforts include the Seismic Retrofit and Historic Restoration of the **Frank Lloyd Wright-designed Hollyhock House**. Currently, Project Restore has embarked on a major restoration and seismic retrofit project of **Residence A**, another significant building designed by Frank Lloyd Wright. Simultaneously, Project Restore's additional restoration efforts include preservation of **Los Angeles City Hall** ceiling murals, ornate bronze and marble work throughout the building.
